- Profitability and the determination of fair or appropriate levels
- Changing market prices, credit terms or discounting strategies
- Allocating markets by specific clients or geography
- Targeting competitors for unfair pricing or sales practices
- Proprietary wage, benefit or other related information, unless it is specifically part of a SCAA approved and sanctioned survey
- Specific company's business or future plans, except public knowledge
- Excluding competitors from joining, unless non-compliance with SCAA acceptance parameters

SCAA Bylaws Change

New Membership Categories

Full Membership: Open to any domestic or international corporation, partnership, sole proprietorship, or individual **actively providing services or products** in support of emergency environmental response, site remediation, risk assessment, contingency planning, environmental investigation, transportation, or other related activities.

Full Members are entitled to all benefits and privileges of the Association, including voting rights and eligibility to hold elected office. Full Membership is separated into clearly defined categories to appropriately scale annual dues.



SCAA Bylaws Change

New Membership Categories (cont.)

Industry Partner Membership: Open to any domestic or international association, corporation, partnership, sole proprietorship, or individual that **utilizes** or **benefits** from emergency environmental response, site remediation, risk assessment, contingency planning, environmental investigation, transportation, or related services.

Industry Partners are valued collaborators in advancing the Association's mission but do not hold voting rights nor eligibility for elected office.

Tiered dues structure – Premium and Supporting.



SCAA Bylaws Change

New Membership Categories (cont.)

Honorary Membership: The Board of Directors of the Association shall be empowered to elect to honorary membership in the Association any individual whose contributions to the environmental services or response industry are deemed to be so unique, and of such a high order, as to warrant special recognition by the bestowal of this honor.

Honorary members shall not have the right to vote, nor to hold elected office. However, if an Honorary Member is part of an organization who is a Full Member, the Honorary Member may have the right to vote and hold an elected office.

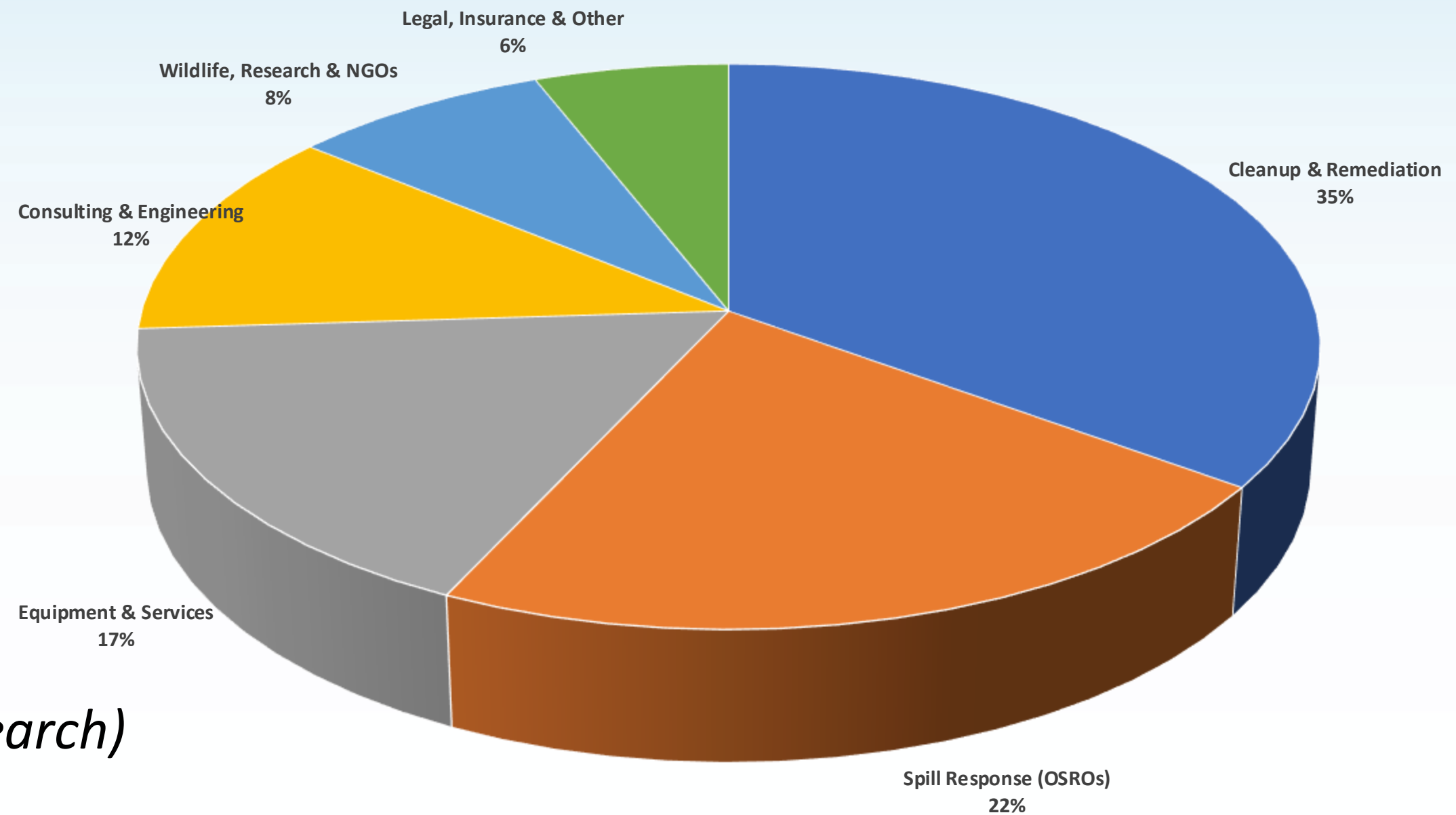
