



# Underwater Ship Husbandry Coordinator

## Job Summary

We are seeking an experienced ship repair / industrial shipyard professional to manage the lifecycle of all equipment and gear in the U.S. Navy SUPSALV's under water ship husbandry "UWSH" portfolio as well as support the project planning for UWSH equipment development. The role will lead coordination and configuration management for design and fabrication of UWSH gear including structural steel barriers like coffer dams or habitats for underwater ship repair, and involve close coordination with engineering, configuration management, maintenance, and procurement departments. The successful candidate will be adept at project planning, cost estimation, and familiarity with marine gear and equipment in a ship repair / shipyard context. This is a full-time position with a long-term Navy contract that oversees the warehousing, maintenance and operation of the U.S. Navy's salvage, pollution control and underwater ship husbandry equipment.

## Major Essential Job Functions

- 10 years of experience in the support of lifecycle management of industrial shipyard equipment or specialized marine equipment.
- Manage and monitor the readiness and maintenance status of all UWSH gear and equipment. Manage lifecycle of UWSH portfolio / inventory including: coffer dams, hydraulics, rigging, welding tools, buoyancy equipment, and underwater inspection tools.
- Oversee the re-certification of preventative maintenance process for equipment and systems to return to service in the field.
- Support development of new equipment and systems including familiarity with equipment maintenance procedures, cost estimating, design and modifications of existing equipment and configuration management procedures.
- Liaise between lifecycle manager on the client side and the engineering team, translating requirements for development projects and supporting cost estimating and planning.
- Estimate time and cost to design, develop/ procure and test equipment and perform procedure development and to monitor scheduled performance against such tasks.
- Perform the equipment development planning activities together with engineering and Navy client (Lifecycle Manager) for the modifications and development of UWSH equipment and gear. Develop program of actions and milestones for UWSH projects – the sequence of activities to complete the development of UWSH gear and equipment.
- Collaborate with engineering and configuration management departments to develop and track budgets for overall UWSH projects including the engineering side, configuration management.



- Work with buyers and engineering to source new equipment, procure components, services and materials for UWSH projects. Manage relationships with subcontractors and suppliers.

### Required Qualifications

- **Minimum Experience:** 10 years of experience in the support of lifecycle management of industrial shipyard equipment or specialized marine equipment.
- **Education:** Undergraduate degree or higher from an accredited university OR 5+ years related experience in lieu of degree.
- **Citizenship:** Eligible candidates must be able to access the work site on a federal installation and is therefore limited to U.S. citizens.
- **Security Clearance:** Must be able to successfully complete a background check and be eligible to obtain a Secret Clearance.

### Preferred Qualifications

- Experience directly relating to underwater ship repair techniques and equipment is preferred.
